

Terms and Conditions

1 YEAR WARRANTY

All claims for parts or labor must be made directly through Babak. All claims must include: model number of the unit, the serial number, proof of purchase, date of installation, and all pertinent information supporting the alleged defect. In case of compressor replacement under warranty, either compressor or compressor tag must be returned to Babak along with above listed information.

Failure to comply with warranty policies will result in voiding claims. One Year Parts & Labor Warranty

Babak warrants all new refrigerated components, such as the cabinet and all parts, to be free from defects in materials or workmanship. Babak's obligation under this warranty is limited to a period of one (1) year from the date of original installation The labor warranty shall include standard straight time labor charges only and reasonable travel time, as determined by Babak.

404A / 134a Compressor Warranty

The three year compressor warranty detailed above will be void if the following procedure is not carefully adhered to:

- $1. This system contains \, R404A \, or \, R134a \, refrigerant \, and \, lubricant. \, The \, lubricant \, has \, rapid \, moisture \, absorbing \, qualities.$
- Drier replacement is very important and must be changed when a system is opened for servicing.
- 3. Micron level vacuums must be achieved to insure low moisture levels in the system.
- 4.Compressor must be obtained through Babak, unless otherwise specified in writing, through Babak's warranty department.
